

TERMS AND CONDITIONS

7-DAY 3-IN-1 PASS FOR POSTPAID ("Promotion")

Introduction

This Promotion is held by Celcom Mobile Sdn Bhd (Company No. 27910-A) ("Celcom"). By participating in the Promotion, the Customers (as herein defined) hereby agrees to be bound by these terms and conditions ("Terms and Conditions") which shall form an integral part and to be read together with terms and conditions of the Fair Usage Policy and/or Customers Registration Form ("CRF") and/or terms and conditions of the respective mobile/content service(s) offered and relevant to the Customers in respect of this Promotion.

In the event of a conflict or inconsistency between these Terms and Conditions and/or terms and conditions of the Fair Usage Policy and/or terms and conditions of the CRF and/or terms and conditions of the respective mobile/content service(s), such inconsistency shall be resolved by giving precedence in the following decreasing order (i) these Terms and Conditions (ii) terms and conditions of the Fair Usage Policy and/or the CRF and/or the respective mobile/content service(s).

Duration of Promotion

Eligibility

2. The Promotion is not available to Customers if they are latched to non-preferred Operators.
3. This Promotion will not be available to Customers if they have any outstanding bills and their service is barred with Celcom.

1. The Promotion is 7-Day 3-in-1 Pass and shall be applicable to Customers provided that:
 - a. Customers shall be responsible to activate the roaming services as per the following applicable standard procedures ("Subscription"):

USSD Subscription;

- STEP 1: Dial *118#
- STEP 2: Choose **Roaming & IDD**
- STEP 3: Select **Buy Roaming Pass**
- STEP 4: Select **7-Day 3-in-1 Pass**
- STEP 5: Select **Buy**
- STEP 6: Customers will receive successful subscription message

SMS Subscription;

STEP 1: Send SMS <WRP138> to **28882**

- b. Customers can subscribe to the package while still in Malaysia or when abroad, the subscription will start on the day of subscription; Customers shall be charged RM138 per week ("Charge") upon subscribing to the package; Customers shall receive unlimited international Calls & SMS and 3GB Internet access once Customers subscribe to the package at selected countries as specified below;

- d. Customers will enjoy 3GB high-speed Internet quota and when Customers have reached 100% Internet usage, Internet roaming will be throttled.
- e. The 7-Day 3-in-1 Pass will expire in seven (7) days from the date of Subscription at 11.59pm (Malaysian Time);
- f. Subscription to the 7-Day 3-in-1 Pass will not be automatically renewed. Customers need to re-purchase it to enjoy the service upon expiry of the Subscription;
- g. In any circumstances when the Operators have no coverage and device steers to the non-preferred network, Internet usage will be blocked, while Voice & SMS will be charged as pay-per-use;
- h. The terms and conditions of Internet usage for both Celcom and the Operators shall apply;
- i. Celcom reserves the right to terminate the Promotion without giving any prior notice to the Customers; and
- j. Celcom does not guarantee the speed or coverage availability during roaming.

Unlimited International Calls and SMS

- 1. The Unlimited Calls & SMS allocated with the 1-Day Calls & SMS Pass applies to :
 - a. Unlimited international Calls and SMS covers calls as per below :
 - i. Calls back to Malaysia via direct dial (Mobile & Fixed Line)
 - ii. Calls within roaming countries via direct dial (Mobile & Fixed Line)
 - iii. Receiving calls (Mobile & Fixed Line)
 - iv. Outgoing SMS & Incoming SMS from any number
 - b. Standard person-to-person Calls or SMS and not for any commercial and /or non-personal usage.

Internet roaming allocation

- 1. For Internet allocation with the 7-Day 3-in-1 Pass:
 - a. Customers are subjected to 3GB Internet roaming data allocation. The roaming usage will be drawn from the allocated allocation.
 - b. The Internet service will be throttled once it has reached 100% usage.

General Terms and Conditions

- 1. Celcom reserves the sole and absolute right to withdraw, amend, omit and/or vary any part or the whole of the Terms and Conditions of this Promotion without prior notice to the Customers herein stated and the Customers shall be bound to observe, perform and comply with the Terms and Conditions herein and any amendments thereof.

2. Celcom's decisions in any matter in relation to the Promotion shall be final and conclusive. Any request for appeal and review shall not be entertained.
